## Feed additives for animals in oral form

### **COMPOSITION:**

Natural components:

- Garlic
- Eucalyptus oil
- Thyme tincture

#### Preservatives and solvents:

- Glycerin
- Purified water

#### USE:

RespiGuard is recommended for prevention and help in treatment of respiratory infections different etiology.

RespiGuard solution contains a high concentration of natural garlic extract and eucalyptus. The active ingredient of garlic is allium sulfate which has antibacterial, antiviral, antifungal, antiparasitic, and anti-inflammatory effect. It strongly supports cardiovascular and immune systems; stimulate lipid metabolism; play a role in the liver protection and regeneration. The sensitive organisms to allium sulfate are as follows: bacteria (E. Coli, Actinobacilus sp., Pasterella multocida., Salmonella sp., Clostridium perfringens, Staphylococcus aureus, Streptococcus sp., Pseudomonas aeruginosa, Klebsiella pneumoniae, Enterococcus faeciumili Camphylobacter sp. Mycoplasma sp.), fungi (Candida sp., Trichophyton sp., Microsporum sp., Cryptococcus sp.), parasites (Cryptosporidium parvum, Entamo ebahistolytica, Giardia lamblia or Leishmania sp.).

Eucalyptus oil expands respiratory pathways and thereby facilitates breathing. The composition has a secretolytic effect, thereby allowing easier release of the products from the respiratory tract infection. Cineol 1.8, compound of Eucalyptus has also very strong antibacterial effect.

Thyme tincture increase immunity status and helps antibacterial effect of RespiGuard. Thyme has strong antibacterial and anti-inflammatory effect, with impact to stimulate immune system, improved absorption of nutrients secure easier breathing.

**TARGET SPECIES:** Pigs, poultry, pigeons, cattle, rabbits and horses

#### DOSAGE:

Poultry, pigs, rabbits: 1L per 2000 I of drinking water or 1L per 1 ton of feed, 7-10 days.

Pigeons: 1ml per 2 L of drinking water, 7-10 days.

Adult cattle: 20-25 ml per animal/daily or 700 ml per 1 ton of feed, 7-10 days.

Calves: 5-9 ml per animal/ daily, divadied into 2 applications, 7-10 days.

Horses: 10-20 ml per animal/daily, 7-10 days.

For complete protection, treatment duration (7-10 days), maybe repeated every three weeks.
